# Community Activators working with participants aged under 18 years of age must

- ✓ Complete the British Triathlon Community Activator Course
- ✓ Hold an appropriate Disclosure and Barring Service (DBS) check with British Triathlon or Protecting Vulnerable Groups (PVG) check with Triathlon Scotland which is suitable for the environment they lead in and has been issued within the last 3 years
- ✓ Complete the UK Coaching Safeguarding and Protecting Children training course (England/Wales) or Child Wellbeing and Protection in Sport training course (Scotland), renew this training course every 3 years and upload your certificate to your British Triathlon membership profile.
- ✓ Hold British Triathlon Home Nation membership
- ✓ Ensure appropriate first aid provision is in place







### Community Activators working with participants aged 18 years or older

- ✓ Complete the British Triathlon Community Activator Course
- ✓ Complete the UK Coaching Safeguarding and Protecting Children training course (England/Wales) or Child Wellbeing and Protection in Sport training course (Scotland), renew this training course every 3 years and upload your certificate to your British Triathlon membership profile.
- ✓ Hold British Triathlon Home Nation membership
- ✓ Ensure appropriate first aid provision is in place







### Requirements for Open Water Activators

Open Water Activators working with participants aged under 18 years of age (Assistant role only)

- ✓ Complete the British Triathlon Open Water Activator Course
- ✓ Hold an appropriate Disclosure and Barring Service (DBS) check with British Triathlon or Protecting Vulnerable Groups (PVG) check with Triathlon Scotland which is suitable for the environment they lead in and has been issued within the last 3 years
- ✓ Complete the UK Coaching Safeguarding and Protecting Children training course (England/Wales) or Child Wellbeing and Protection in Sport training course (Scotland), renew this training course every 3 years and upload your certificate to your British Triathlon membership profile.
- ✓ Hold British Triathlon Home Nation membership
- ✓ Ensure appropriate first aid provision is in place

### **Requirements for Young Person Activator**

#### **Young Person Activators**

- ✓ If you are 16 years of age or older and supporting in sessions where participants are under the age of 18 years of age you will require an appropriate Disclosure and Barring Service (DBS) check with British Triathlon or Protecting Vulnerable Groups (PVG) check with Triathlon Scotland which is suitable for the environment they lead in and has been issued within the last 3 years.
- ✓ Complete the Young Person Activator Course
- ✓ Hold British Triathlon Home Nation membership
