



**Scottish Selection Policy for British Triathlon School Games 2019**  
**Parc Bryn Bach August 3**

**OVERVIEW**

This Selection Policy (“the Policy”) outlines the process by which the British Triathlon Federation (“BTF”) will determine its individual selections for the British Triathlon School Games 2019

This Policy has been structured to support BTF’s Olympic World Class Performance Programme’s (“WCPP”) vision of delivering world class success and inspiring the nation. Specifically, this means that all selection policies for BTF Junior and Youth competition intend to:

- select the right athletes, to the right race, at the right time;
- provide competition opportunities appropriate to an athlete’s age and stage of development; AND
- support the development of athletes with the necessary experiences (Intelligent Racing & One Day One Race) for senior success at Olympic and World level.

**SECTION 1: ELIGIBILITY**

1.1. To be considered for nomination to the British Triathlon School Games athletes need to;

- a. Be aged 15 or 16 on 31 August 2019;
- b. Be a member in good standing with Triathlon Scotland which is a member of the BTF and eligible to represent Great Britain in international championships under the rules of the ITU; AND
- c. Not be serving a period of ineligibility as a result of an anti-doping rule violation.

NB While nomination for Youths is not mandatory for this event athletes should be aware of the necessary nomination requirement for other events e.g. ETU Junior Cups and all Senior events as they progress.

**SECTION 2: SELECTION PROCESS**

2.1 A team of 2 male and 2 female athletes will be selected for Scotland on or before June 14.

2.2 A Selection Panel (“the Panel”) will convene either via email or conference call and shall comprise of:

- a. Voting members;
  - i. Scottish School Games Team Lead; AND
  - ii. 1 Triathlon Scotland Performance Programme staff member.
- b. Non-voting members (all nations/regions):
  - i. Note taker(s) if/as required.

### 2.3 Automatic selections

- a. Subject to the criteria outlined at paragraph 3.1 below (relating to exceptional circumstances etc.) the first eligible finisher from Scotland in the Youth event at Blenheim will be **automatically selected**.

### 2.4 Discretionary selections

- a. Following completion of the automatic selections, the Panel will select 1 additional eligible male and 1 additional eligible female athlete using the process outlined below.
  - i. The Panel will select the eligible athletes' single best performance across Blenheim and Llanelli.
  - ii. The Panel will then compare those performances and select the athletes deemed to have the best overall performance. If (male) athletes are being compared across different Tiers (Llanelli), the athlete with the fastest overall time - irrespective of the Tier - will be prioritised.
  - iii. In the case that none, or insufficient, eligible athletes compete at Llanelli or Blenheim, performances at the following will then be considered using the process set out at 2.4(a[i-ii]) above:
    - a. 2019 Performance Assessment Weekend;
    - b. The 2019 Scottish Series.

## **SECTION 3: CONDITIONS OF SELECTION AND ALTERNATIVE SELECTION RACE PROVISIONS**

- 3.1 The Panel reserves the right NOT to ratify nominations via the Automatic Nomination Criteria, should a performance that qualifies an athlete for automatic nomination have been achieved in a race which was, as determined solely by the Panel, **significantly impacted by**:
  - a. a large-scale racing incident (such as a crash); OR
  - b. an anomalous incident, usually completely outside of the athletes' control, that seriously affects the result (such as a stray dog/vehicle on the course) - please note, this does NOT include individual mechanical issues.

If this is the case, affected athletes may appeal to a Scottish Triathlon Performance Team member of staff within 30 minutes of the last person finishing their race detailing mitigating circumstances.

The Panel will consider those athletes with a validated appeal by means of a projected result, the result being added to those being considered at 2.4.a.ii. In such cases the decision of the Panel would be final.

- c. In the event of environmental conditions/exceptional circumstances which result in a dramatically altered or reduced race format (such as removal of the swim portion) the following events will be used for

Automatic selection;

- i. No Automatic selection as per 2.3

Discretionary selection;

- i. Performance Assessments 2019 (applied as set out at 2.4(a) above in conjunction with the other unaltered event.

#### **SECTION 4: APPEALS**

- 4.1 There shall be no right of appeal against the selections decisions made by the Panel under this Policy. The provisions of the BTF Selection and Nomination Appeals Procedure do not apply to the British Triathlon School Games. However, athletes who feel that they should have been selected are encouraged to contact the Panel to discuss their case. In addition, any athlete who wishes to seek independent advice regarding the selection process in general are advised to contact the British Athletes Commission (BAC) at [www.britishathletes.org](http://www.britishathletes.org).

#### **SECTION 5: AMENDMENT**

- 5.1 In the event that any unforeseen circumstance makes any provision of this Policy unworkable or ineffective to promote the aims of the Policy, the BTF will be entitled to amend this Policy so that the aims can be secured.
